

The Normanna Annual Meeting was called to order on March 12, 2013 by Paul Hanson, Deputy Clerk, at 8:15 p.m. at the Normanna Town Hall.

Pledge of Allegiance: All present recited the Pledge of Allegiance.

Election of Moderator: P. Hanson asked for nominations for a moderator. A motion was made by Dennis Gunsolus and seconded by Vivian Hanson, to elect Bob Spehar as Moderator. This motion passed unanimously.

Minutes of 2012 Annual Meeting: A motion was made by Julie Johnson and seconded by Lone Cooke to waive the reading of last year's annual meeting minutes, and to approve those minutes. This motion passed unanimously.

Report of 2012 Receipts and Disbursements: P. Hanson reported that the summary of receipts and disbursements report was available to read at this meeting.

Clerk's Report: Deputy Clerk Paul Hanson delivered the Report of Normanna Township Clerk Ellen Hanson.

Fire Department Report: Copies of the report were available for the public to read. Eric Norland presented the Fire Department Report at this meeting.

Building and Grounds Report: Copies of the report were available for the public to read. Supervisor Dan Johnson presented the Building and Grounds Report at this meeting.

Building Committee Report: Supervisor Dennis Gunsolus presented the Building Committee Report at this meeting.

Road and Bridges Report: Copies of the report were available for the public to read. Supervisor Dan Johnson presented the Road and Bridges Report at this meeting.

Cloquet Valley Internet Initiative: Supervisor Kimberly Grubb presented the Cloquet Valley Initiative Internet Report at this meeting.

2013 Election Results: A total of 31 township resident votes were cast. Supervisor (3 year term) Daniel Johnson = 28, Write-ins = 2, Blank Ballots = 1.

Setting of the 2014 Levy Amounts: Supervisor Dan Johnson presented the proposed 2014 Normanna Township Levy amounts. They were: General Fund = \$25,000, Fire Department Fund = \$20,000, Road and Bridge Fund = \$25,000, Building Fund = \$5,000, Cemetery Fund = \$1,000, Impress Fund = \$200. A motion was made by Mark Anderson and seconded by Michael Gunsolus to accept the proposed levy amount for the General Fund of \$25,000. This motion passed unanimously. A motion was made by Dan Boniver and seconded by Vivian Hansen to accept the proposed levy amount for the Fire Department Fund of \$20,000. This motion passed by a majority vote. A motion was made by Lone Cooke and seconded by Clarke Peterson to accept the proposed levy amount for the Road and Bridges Fund of \$25,000. This motion passed unanimously. A motion was made by Diane Spehar and seconded by Dan Boniver to accept the proposed levy amount for the Building Fund of \$5,000. This motion passed unanimously. A motion was made by Bill Prudhomme and seconded by Kathy Potts to accept the proposed levy amount for the Cemetery Fund of \$1,000. This motion passed unanimously. A motion was made by Paul Hanson and seconded by Leah Hulst to accept the proposed levy amount for the Impress Fund of \$200. This motion passed by a majority vote. The total 2014 levy is \$76,200.

Petitions from the Floor: None.

Set Time and Place for the 2014 Annual Meeting: A motion was made by Lone Cooke and seconded by Dan Boniver to hold the 2014 Normanna Township Annual Meeting at 8:15 p.m. on March 11, 2014 at the Town Hall unless it is a snow day. Motion passed unanimously.
